1           SUPERVISOR WROBLEWSKI: I call to order this  
2 public hearing.

3                   Highway Commissioner Kegarise is  
4 here to answer any questions about the Road District  
5 budget for the fiscal year beginning March 1, 2017  
6 and ending February 28, 2018.

7                   Does anyone have any questions?

8                                           (No response.)

9           HIGHWAY COMMISSIONER KEGARISE: No questions?  
10 Come on, ask me one question.

11           MS. ROMANOW: I have a question.

12                                   Why is it our --

13           SUPERVISOR WROBLEWSKI: State your name and  
14 address.

15           HIGHWAY COMMISSIONER KEGARISE: You have to  
16 state your name and your address.

17           MS. ROMANOW: My name is Anna Romanow, I'm at  
18 1311 Mohawk Court, Schaumburg, Illinois,  
19 Unincorporated Schaumburg Township.

20                                   They have never paved our street.

21 Is that a question to address to you?

22           HIGHWAY COMMISSIONER KEGARISE: You could, if  
23 it were my street.

1 MS. ROMANOW: Well, I ask the Village, and  
2 they say it's your street. If I ask you, you say  
3 it's their street.

4 HIGHWAY COMMISSIONER KEGARISE: We did a  
5 pipe -- We didn't do a pipe to your house. We had --  
6 I called a favor in and got somebody to do it for you  
7 because that little stretch of Mohawk -- I think it's  
8 Mohawk, right?

9 MS. ROMANOW: Right.

10 HIGHWAY COMMISSIONER KEGARISE: You can't --  
11 That's a Village street and not a Township street.

12 MS. ROMANOW: Well, what does that mean?

13 HIGHWAY COMMISSIONER KEGARISE: It means that  
14 they're responsible to maintain and plow.

15 Now, what we do for you is because  
16 you live on a Township property, unincorporated, we  
17 can pick up your trash -- not your trash, but your  
18 brush, which we do; and we could provide a pipe for  
19 your driveway, which we did; but we couldn't do the  
20 work.

21 No one wanted to take responsibility  
22 on your house for doing that, and I called a favor in  
23 from someone.

1 MS. ROMANOW: I know. We appreciate that.

2 We're talking about the street, who  
3 is responsible for the street?

4 HIGHWAY COMMISSIONER KEGARISE: That would be  
5 the Village of Schaumburg.

6 SUPERVISOR WROBLEWSKI: If you have any  
7 questions, just tell them to call Mr. Kegarise.

8 HIGHWAY COMMISSIONER KEGARISE: Call Mary  
9 Wroblewski.

10 SUPERVISOR WROBLEWSKI: That's fine, and I  
11 will send them right to you.

12 MS. ROMANOW: It's in the minutes, so you  
13 have to call.

14 HIGHWAY COMMISSIONER KEGARISE: If you have a  
15 question, and you want to call me, call me.

16 You want my cell phone number (847)

18 MS. ROMANOW: Thank you.

19 SUPERVISOR WROBLEWSKI: Now it's in the  
20 public record.

21 HIGHWAY COMMISSIONER KEGARISE: That's right.  
22 It's publically listed.

23 SUPERVISOR WROBLEWSKI: Any other questions?


